# RULES FOR ACCESS IN FARM OR IN FIELD 002-ter\_CDICV\_v3\_04-2020\_ENG INFORMATION LEAFLET FOR THE CONTRAST TO THE SPREAD OF SARS-CoV-2 VIRUS

## **1) ATTENTION TO THE SYMPTOMS OF INFLUENCE**

Stay home in presence of fever (over 37,5  $^{\circ}$  C) or other flu symptoms Accept the check of your body temperature at entrance and before your departure towards the field

Promptly report the appearance of flu symptoms to your employer or his contact person, staying at an adequate distance from other persons. Put on preventively the mask. Follow instructions as received and communicate your "close contacts"





## **1 2) EXPOSED PERSON**

Report your arrival from high-risk areas or with a high percentage of COVID-19 cases

Report immediately any contact with COVID-19 cases in the previous 14 days

3) HYGIENE AND PERSONAL CLEANING

Wash your hands frequently and for a long time with soap and water

Do not touch your eyes, nose or mouth with dirty hands

## 4) COMPLIANCE WITH RULES AND COMPANY PROTOCOL

Check of your body temperature at entrance

TAKE VIEW of the company Protocol, prepared by the employer as required by the Government-Social Partners Agreement, delivered and/or exposed

Be aware of the main hygienic-sanitary rules to follow for your own and others' safety

Keep the safety distance and always use mask and gloves at least up to the safety distance. Check for any other more restrictive distance and/or additional PPE imposed by the employer

Never create gatherings of people

Be careful of contact with surfaces and objects just handled by others, in this case use protective gloves

Pay particular attention to hand hygiene

**Use dedicated toilets** 

Pay particular attention to the use of toilets, changing rooms, refreshment area, canteen, offices and any other area of common use or small closed spaces. Strictly follow the instructions of the employer

Give preference to outdoor lunch breaks if possible

Limit movement within the company or the field

TAKE VIEW of all prepared, delivered and/or displayed information notes

Throw "anti-contagion PPE" in the appropriate baskets, set up by the employer

## 5) IN BUSINESS TRIPS - TRAVEL - WORK OUTSIDE

Bring with you the self-declaration provided by the employer

Always use at least mask and gloves in public or open to public places

Inside the vehicle, keep as much distance as possible (at least 1 m) and use mask and gloves. If this distance cannot be guaranteed, use the specific PPE provided by the employer. Leave the windows slightly open to ensure a change of outside air. AIR RECIRCULATION IS FORBIDDEN

Travel the shortest route and do not stop if not strictly essential

Reached the external venue (or field), respect rules and behaviors planned and/or required by the company Protocol

Respect all the indications and rules exposed in the previous points 1, 2, 3

Always have with you the "anti-contagion PPE" kit (mask, gloves, hand sanitizer gel and any other PPE, if necessary), to be used in cases as provided
